

DEFINITION OF ETHICAL MATURITY (CARROLL, M & SHAW, E. P. 30)

"the reflective, rational, emotional and intuitive capacity to decide actions are right and wrong, or good and better; the resilience and courage to implement those decisions; the willingness to be accountable for ethical decisions made (publicly or privately); and, the ability to learn from and live with the experience"

HOW MIGHT I MAKE LESS ETHICALLY MATURE DECISIONS?

- Can I get away with it?
- Will anyone notice?
- Compared to the significant ethical decision others are making, this decision seems small or insignificant
- Everyone else is doing it
- Maybe one day I will spend more time on this decision
- I need to compromise
- It won't make a difference because I am such an insignificant piece of the whole
- No one will be hurt by my actions

HOW TO AVOID BEING UNETHICAL (P. 20)

- Think 'we" vs "I"
- Consider issues of power, domination, privilege, and how they might move into abuse and harm of others
- Consider whether you would recommend your own action to others
- Consider looking at behaviour (and impact), not only intention
- Consider how others might perceive the actions/decision
- Consider the opposite action/decision
- Ask yourself: "What are my ways and habits of denial"?
- Identify your Achilles heel
- Beware of any extremity of your ideals (e.g. Fundamentalism)
- What kind of ancestor do I want to be? The "grandchildren/future generations" test

THEMES OF CONCERN: 10% Breach of confidentiality 15% Not maintaining appropriate 50% boundaries General business disputes 25%
